Deposits and Refunds:

A \$500.00 retainer fee is required at the time of making your reservation. This fee reserves a hunt slot contingent on the license draw. Once you draw your license this fee becomes nonrefundable and is applied to your hunt. For elk, sheep, goat and moose, an amount equal to 50% of your hunt is due within 30 days after the draw. The remaining balance of your hunt is due 60 days before your arrival in Cody or Jackson. For deer and antelope, the entire balance of your hunt is due 30 days after the draw. If you do not draw a license, the \$500.00 will be refunded to you within 30 days or held to book a hunt the following year, if you desire. Once you draw your license, Crescent B Outfitters will be making arrangements for your guide and lodging. **This is a legal contract for services. Once you draw your license, the entire balance of this contract is owed Crescent B Outfitters, regardless of whether you actually show up for your hunt or not. Unpaid balances will be turned over for collection. You will also bear all collection costs.**

Waiver and Release:

In booking a trip and in consideration for my being permitted to participate in the activities offered by Crescent B Outfitters and the use of the equipment and animals, I agree to the following waiver and release:

I acknowledge that horseback riding has inherent risks, hazards and dangers for anyone that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The propensity of the animal to behave in ways that may result in injury, harm, or death to the person(s) around them;
2. The unpredictability of the animal's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
3. Certain hazards such as surface and subsurface conditions;
4. Collision with other animals or objects;
5. The potential of the participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability. I may encounter variations in terrain that are my responsibility and I assume these risks including creeks, water, bridges, traveled roads, wild things, stumps, forest growth, debris, rock and cliffs, and other obstacles whether they are obvious or not obvious, man-made or natural;
6. Hiking in rugged country;
7. Encounters with wildlife, animals and insects;
8. Temperature extremes;
9. Inclement weather conditions and the unavailability of immediate medical attention in the wilderness in case of injury;

In making this reservation, I affirm that my personal health is good, that I am capable of performing the physical exercise needed to hunt or ride a horse, and that I accept as my personal risk the normal hazards of hunting and horse riding, and will not hold Crescent B Outfitters responsible for injuries or illnesses resulting from such hazards.

Weather:

Wyoming weather is unpredictable. Crescent B Outfitters will not be held responsible for any weather condition affecting your hunt.

Acts of God, Terrorism, War or Fire:

In the event a trip is cancelled due to an act of God, terrorism, war or fire, Crescent B Outfitters will not be liable for loss of deposits, airline fees or other travel expenses.

Cessation of Trip:

Crescent B Outfitters reserves the right to terminate the trip of any person who:

- Fails to adhere to Crescent B's rules and guidelines;
- Endangers any other guest, member of our staff, or animals; or
- Engages in behavior deemed to be offensive to other guests.

Cessation of trip will result in no refund of any amounts paid.

Litigation:

In the unfortunate event that litigation becomes necessary regarding this contract or your hunt, any litigation shall occur in the State of Wyoming.

CRESCENT B OUTFITTERS WILL DO EVERYTHING IN ITS POWER TO MAKE YOUR HUNT SUCCESSFUL. HOWEVER, SUCCESSFUL HUNTS ALSO REQUIRE PHYSICAL AND MENTAL PREPARATION ON THE HUNTER'S PART. YOUR HUNT WILL BE MORE ENJOYABLE AND SUCCESSFUL IF YOU PREPARE IN ADVANCE FOR YOUR TRIP. GET IN SHAPE (IF YOU SMOKE – QUIT!), RIDE A HORSE (A LOT), SHOOT YOUR GUN, AND BREAK IN YOUR BOOTS. *AND MOST IMPORTANTLY, BRING A POSITIVE ATTITUDE WITH YOU – A SENSE OF HUMOR IS A MUST WHEN DEALING WITH NATURE AND WEATHER!*
